RESOLUTION NO. B-2024.06.25.08

“A RESOLUTION RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY (HOPE) TO AWARD THE FRAMEWORK AGREEMENT OF PURCHASE REQUEST NO. 24-C1142 TO JUNIEL'S FARM & AGRIVET SUPPLIES AS THE LOWEST CALCULATED AND RESPONSIVE BIDDER FOR THE PROCUREMENT OF SUPPLY AND DELIVERY OF FEED INGREDIENTS UNDER BID NO. B-24-0131 FOR A PERIOD OF ONE (1) YEAR.”

WHEREAS, the Bids and Awards Committee (BAC) of Provincial Government of Davao de Oro conducted a Public Bidding for the procurement of **SUPPLY AND DELIVERY OF FEED INGREDIENTS** with an Approved Budget of the Contract (ABC) of Four Million Two Hundred Thirteen Thousand Six Hundred Thirty Seven Pesos (PhP 4,213,637.00) under Framework Agreement procurement method in accordance with Republic Act No. 9184 and its Implementing Rules and Regulations (IRR);

WHEREAS, the Provincial Government of Davao de Oro advertised the Invitation to Bid for the procurement of **SUPPLY AND DELIVERY OF FEED INGREDIENTS** under Bid No. **B-24-0131** POSTED on its website, the PHILGEPS, and at a conspicuous place within the premises of the Provincial Government of Davao de Oro continuously for seven (7) calendar days;

WHEREAS, a pre-bidding conference was held with the prospective bidders on May 28, 2024, during which the BAC informed them about the guidelines governing the Framework Agreement;

WHEREAS, the BAC pursuant to Section 30 of R.A. 9184 used the nondiscretionary pass/fail criteria and conducted public bidding on June 11, 2024, that were attended by the following bidders/suppliers, to wit;

WHEREAS, the Committee agreed that **JUNIEL'S FARM & AGRIVET SUPPLIES** shall undergo post-qualification by the Technical Working Group for being the lowest bidder and to determine whether the bidder complies with and is responsive to all requirements and conditions as specified in the bidding documents;

WHEREAS, the detailed evaluation of bids conducted on June 19, 2024, resulted in the following;

WHEREAS, if the BAC determines that the bidder with the Lowest Calculated Bid passes all the criteria for post-qualification, it shall declare the said bidder as LCRB and recommend to the HoPE the award of contract to the said bidder at its submitted bid price or its calculated bid price, whichever is lower, as stated in Section 34.4 of the IRR;

WHEREAS, the Framework Agreement between a Procuring Entity and a supplier or service provider outlines the terms and conditions under which specific purchases, known as "Call-Offs," are made for the duration of the agreement. This agreement acts as an option contract, allowing the Procuring Entity the flexibility to either place an order for any of the goods or services listed in the Framework Agreement or choose not to make any purchases at all. The agreement spans a minimum period of one (1) year to a maximum period of three (3) years, in accordance with GPPB Resolution No. 27-2019.

WHEREAS, upon careful examination, validation, and verification of all the eligibility, technical, and financial requirements submitted by the bidder as a Lowest Calculated Bid, its bid has been found to be responsive.

NOW THEREFORE, We, the members of the Bids and Awards Committee, hereby **RESOLVE**, as it is hereby **RESOLVED**:

- a) To recommend to the Head of the Procuring Entity (HoPE) to award the Framework Agreement of Purchase Request No. **24-C1142** to **JUNIEL'S FARM & AGRIVET SUPPLIES** as a Lowest Calculated and Responsive Bidder for the procurement of **SUPPLY AND DELIVERY OF FEED INGREDIENTS** under Bid No. **B-24-0131** for a period of One (1) year;
